## Grants for persistent pelvic pain eLearning course for General Practitioners (GPs)



## **Grant Guidelines**

Primary Health Tasmania is offering educational scholarships for GPs working in Tasmania with an interest in Persistent Pelvic Pain (PPP) and Endometriosis to complete the Vagenius eLearning course on the treatment and management of PPP and endometriosis.

Primary Health Tasmania will fund the entire cost of enrolment into this course directly to the training provider.

## The course: Persistent Pelvic Pain – Leadership in Care

#### RANZCOG, RACGP, RNZCGP, and ACRRM approved. Endorsed by ACNP.

The course offers a self paced virtual learning enviornment and is RACGP accredited CPD hours totalling 15.5

- 9 Hours Educational Activities
- 1.5 Hours Reviewing Performance
- 5 Hours Measuring Outcomes

This structured and practical course supports GPs in the diagnosis, treatment and management of persistent pelvic pain, including making a presumptive diagnosis of endometriosis. It is accessible online and is tailored for GPs wherever they practice. It includes trauma informed, culturally safe practice, communication and validation, with GP and clinician-led learning modules, specialists' input, real case studies and more. Approached in a systematic, structured way, the course can be completed at a participant's own pace, across all devices, picking up where they left off.

The course also includes two peer group learning sessions per year.

There are six modules broken into learning outcomes, which provide structured, practical learning in the treatment and management of PPP.

- Module 1 Why have a course on Persistent Pelvic Pain (PPP)
- Module 2 Exploring the history further
- Module 3 Examinations and investigations: thinking outside the box
- Module 4 How to reduce pain with pain science education
- Module 5 GP management of PPP and team leadership
- Module 6 Collaborative care planning: maintaining care and moving forward

- Applicants must address all required fields in their application.
- Applications will be reviewed on a **first-come**, **first-served basis**, ensuring early submissions are prioritised for evaluation.
- Timely submissions facilitate a fair and efficient process while allowing for prompt decision-making.
- Applications will be assessed based on their distribution across different areas within the state to ensure equitable representation.
- Consideration will be given to geographic diversity, ensuring that initiatives or solutions benefit a broad range of communities within the state.



## Out of scope activities

Funds provided by Primary Health Tasmania **cannot** be used for any other course that is not the Vagenius Persistent Pelvic Pain – Leadership in Care eLearning course.

Grants will not be provided to applicants:

- that are based outside of Tasmania
- that are not currently practicing as a GP
- if the enrolment is beyond 30 June 2025
- for travel/meal/accommodation costs
- for retrospective courses or courses in progress (already commenced).

# Grant reporting requirements

All scholarship recipients will be required to complete a pre and post course survey by Primary Health Tasmania.

- Applications open 13 February 2025 and close 30 April 2025
- Courses may commence at any time after notification of successful application
- Grant activity must be completed by 30 June 2025.

## **Primary Health Tasmania procurement terms and conditions**

#### (1) Definitions

**Applicant** is an authorised delegate who can submit an Application on behalf of a business.

**Application** is the written response submitted via MS Forms.

**Close date and time** is the final closing date and time (Tasmanian time) to submit an Application.

**Requirement** means what the applicant must address in Market Release documents.

#### (2) Information for applicants

#### (3) Application preparation

Applicants must follow the instructions within the Application Form and ensure attachments are in a Microsoft word, excel or PDF format. Incomplete or hard copy documents will not be accepted by PHT.

#### (4) Application upload

Please consider the time zone difference if applying from other states and/or territories.

PHT is not obligated to accept any applications that have not been completed on time or caused by complications such as technical failures.

#### (5) Application validity

All applications must remain valid and open for acceptance for a minimum of 90 days from the closing time.

This period may be extended by mutual agreement between PHT and the applicant.

#### (6) Application acknowledgement

Upon the receipt of an application, applicants will receive an email confirming the application has been received.

#### (7) Late application

Any attempt to submit an application after the closing date will not be accepted by PHT.

#### (8) Evaluation panel

PHT will form an evaluation panel comprising of members chosen for their relevant expertise and experience and may include external parties to evaluate the applications or provide advice.

#### (9) PHT clarification

PHT may seek further information from the applicant after the close date. Any requests for information will be issued by the PHT procurement team to the contact person listed on the application form.

#### (10) Right to negotiate

PHT reserves the right to negotiate with applicant(s) after the close date to allow alterations to an application.

#### (11) Conflict of interest

The applicant must declare to PHT any matter or issue which is, may be perceived to be or may lead to a conflict of interest regarding their application or participation in the services described.
