This informative event will provide valuable insights, evidence-based strategies, and practical guidance on the deprescribing of antidepressants followed by a thought-provoking Q&A session.

Increasing rates of antidepressant prescribing worldwide have raised concerns among healthcare and regulatory organisations. Australia has relatively high rates of antidepressant prescribing, with Tasmania exceeding the national average.

This informative session will focus on adult hernias, providing an overview of their diagnosis, management, and surgical treatment options. It will cover the basics of simple hernias, as well as the eligibility criteria for complex hernia surgery, including key factors like BMI, smoking habits, and blood sugar levels. Dr. Ferrah will use a case study to delve into the nature of complex hernias, explaining how they develop and how to effectively manage them. Key topics of this webinar include the aetiology and risk factors of complex hernias, diagnostic workup, pre-surgical optimisation, management strategies, surgical techniques, post-operative care, potential complications, and handling emergency situations. Attendees will also gain insights into the recovery process and long-term outcomes. The session is designed to provide a clear, accessible approach to understanding and treating complex hernias.


